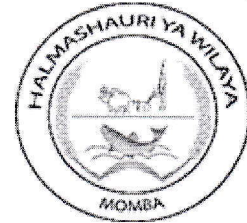

3. Tendering will be conducted through the National Competitive Tendering specified in the Public Procurement Regulations, Government Notice No.446 of 2013 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
4. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the **Secretary of the Tender Board Momba District Council, P.O Box 273 Momba** from 8.00am to 03.30pm Local hours on Monday to Friday except on public holidays.
5. A complete set of Tendering Document (s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 4.
6. All Tenders must be accompanied by a Tender security in an acceptable form in the amount of TZS. 60,000,000/= (Tanzania Shilling Sixty million. Only).

All Tenders in one original plus three (3) copies properly filled in, and enclosed in plain envelopes must be delivered to the address **Tender Board Secretary, Procurement Management Unit, Tindingoma Chitete, Momba District Council, P.O Box 273 Momba Songwe** at or before **12.30pm local time on 10th September, 2021**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the **Momba District Council, Procurement Management Unit at Tindingoma Chitete, P.O Box 273 Momba**.
8. Late Tenders portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
